### Internal Complaints Committee (ICC)

The Principal of the Institute shall nominate members of the Committee. The members of the Committee are:

- (3) <u>One member</u> from an NGO (non-government organization or association) committed to the cause of women or a person familiar with issues pertaining to sexual harassment.

In the event that a situation with a flavor of sexual harassment devastates a woman employee of this Institute, she can hand in a written complaint to this Committee within a period of three months from the date of the incident or the last incident of a series of incidents.

As APJ Abdul Kalam Technological University stipulates the formation of 'Women's Forum" ICC shall work in close association with it.
