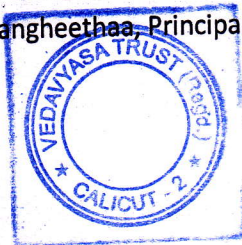
Responsibility of the Cell

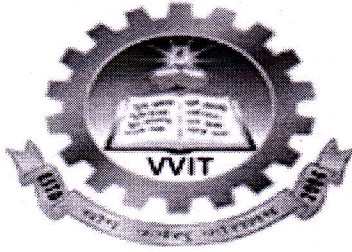
- To examine the accounts, the progress of expenditure and all new proposals involving fresh expenditure in the light of provisions made.

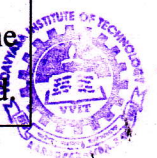
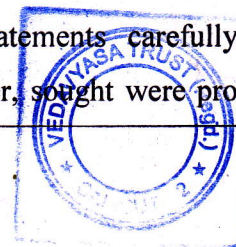

## MINUTES OF FINANCE COMMITTEE





The finance committee meeting of Vedavyasa Institute of Technology is held on 12.07.2021 at 10.30 a.m. in the administrative office.
