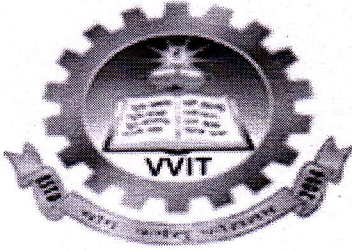
Responsibility of the Cell






The finance committee meeting of Vedavyasa Institute of Technology is held on 01.06.2018 at 10.30 a.m. in director's office.
