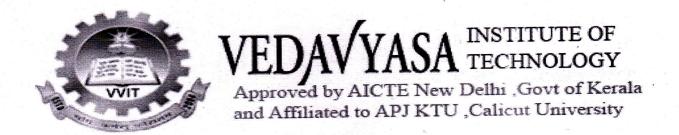
Responsibility of the Cell
