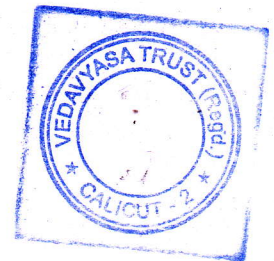

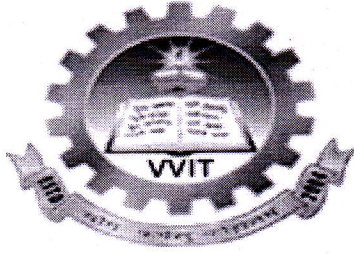
Responsibility of the Cell

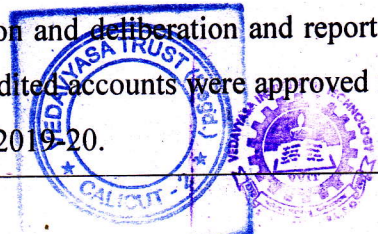

The finance committee meeting of Vedavyasa Institute of Technology is held on 08.07.2020 at 11.00 a.m. in the administrative office.







3) Approval of action taken report of the finance committee meeting dated 14.06.2019	The committee went through the action taken report of the previous finance committee meeting and it was noted and approved.






